



INSTRUCTIONS FOR PARKING PERMIT HOLDERS  
NON-RESIDENTS  
MURRAY HILL PARKING LOT ONLY

The parking permit decal is made of a static-cling material that adheres to glass. If you need to use another car, the decal can be peeled off and easily put on another car window. If the decal does not stick, spray window cleaner on the glass and the decal, or use adhesive tape.

**IT IS THE PERMIT HOLDER'S RESPONSIBILITY TO TRANSFER  
THE DECAL TO ANOTHER CAR IF THE NEED ARISES.  
FAILURE TO DO SO MAY RESULT IN ISSUANCE OF A SUMMONS.**

1. Parking is permitted at the Murray Hill train station parking lot only. Non-Residents are not permitted to park in the New Providence train station parking lot.
2. The decal must be displayed on the driver-side rear window.
3. Clear leaves, snow and debris from rear window so the decal is clearly visible. Borough Ordinance 178-4 states (in part) "...parking permit must be kept visible at all times while parked in the municipal public parking lot".
4. Parking is permitted between the hours of 5:00 a.m. and 2:00 a.m. Cars may not be parked overnight. If you are unexpectedly detained past 2:00 a.m., you must call the Police Department (908) 665-1111.
5. All permit holders must park HEAD-ON, within the lines of a designated parking space.
6. The fine for parking without a permit is \$40.00 for the first offense.
7. There is a \$5.00 charge for lost decals.
8. Refund Policy: \$225 for each remaining full quarter.  
Refunds will only be granted if the permit holder requests the refund before the start of a quarter. Chapter 147 of the Borough Code reads "Two Hundred Twenty Five Dollars (\$225) for each remaining full quarter, only when an annual permit is purchased, or when the quarter has not yet begun for a quarterly permit." Permit holder must make request in writing and return the permit decal with the request.

It is the permit holder's responsibility to renew parking permits on time. The permit dates are:

April 1 <sup>st</sup> to June 30 <sup>th</sup>	First Quarter of Each Year
July 1 <sup>st</sup> to September 30 <sup>th</sup>	Second Quarter of Each Year
October 1 <sup>st</sup> to December 31 <sup>st</sup>	Third Quarter of Each Year
January 1 <sup>st</sup> to March 31 <sup>st</sup>	Fourth Quarter of Each Year
