**THIS MATTER** having been opened to the Court for a Case Management Conference in advance of the Compliance Hearing pursuant to and in accordance with East/West Venture v. Borough of Fort Lee, 286 N.J. Super. 311 (App. Div. 1996); and sufficient notice of this hearing having been given in accordance with In the Matter of the Adoption of N.J.A.C. 5:96 & 5:97 by the New Jersey Council on Affordable Housing, 221 N.J. 1 (2015) (“Mount Laurel IV”) and Morris County Fair Housing Council v. Boonton Tp., 197 N.J. Super. 359 (Law Div. 1984) scheduled by the Court for October 3, 2017; and Steven A. Kunzman, Esq. appearing for the Borough of New Providence, in the presence of Kevin D. Walsh, Esq., attorney for Interested Party, Fair Share Housing Center, Inc. (hereinafter “FSCH”), and the Court Appointed Special Master, Elizabeth C. McKenzie, A.I.C.P., P.A., and no other persons having appeared, and the Court having determined that the Compliance Hearing is required to be rescheduled;

IT IS on this 22<sup>nd</sup> day of August 2017, **ORDERED** that:

1. The Final Compliance Hearing shall take place on October 3, 2017 at 11:30 AM;

2. Any objections to the Borough's implementation of the Court Approved Settlement must be filed with the Court on or before September 12, 2017, with copies provided to counsel for the Borough, counsel for FSHC, and the Special Master.
3. All other provisions of the January 30, 2017 Order scheduling the initial Compliance Hearing remain unchanged except as set forth herein;
4. The Borough shall publish this Order in Two (2) newspapers and it shall be served upon all parties on the service list in this matter, and shall be posted on the Borough's website on or before September 3, 2017.;
5. The Borough shall submit a proof of service at or prior to the date of Compliance Hearing.
