Press Release: July 12, 2011

06-25-2011- The street sign at 5th Street and Pleasantview Avenue was reported stolen.

06-26-2011- A resident of Summit reported while picking up food from a New Providence restaurant, her vehicle was entered but no items were taken. The matter was forwarded to the New Providence Detective Bureau.
