## *Press Release: December 1, 2011*

11-17-2011- A resident of Pleasantview Avenue reported her vehicle was burglarized and the credentials were stolen sometime during the early morning hours of December 16<sup>th</sup>. The burglary is currently under investigation by the Detective Bureau.

11-17-2011- Detective Stephen Drown charged Roberto Alvarado, age 28, of Plainfield with driving while suspended after he was stopped for failing to maintain the lamps on his vehicle.
