Press Release: December 7, 2012

11-17-2012- Sergeant Daniel Henn arrested Ashley Hildebrand, age 19, of New Providence with driving while intoxicated after Ms. Hildebrand struck a parked vehicle while operating her vehicle. Sergeant Henn arrested Ms. Hildebrand after an investigation into the incident. She was charged with driving while intoxicated and for using a cell phone without a hands-free device. She was released to a responsible party pending a municipal court date.

11-19-2012- Patrolman Andrew Diamond charged Jason Hoholik, age 23, of Fairfield with operating a vehicle while his license was suspended after he was stopped for careless driving.
