Press Release: January 31, 2014

01-18-2014: Corporal Chad Wilson charged Alexis Mongiello, age 20, of New Providence for underage possession of alcohol after Corporal Wilson approached a vehicle Ms. Mongiello was in for suspicious activity. At 12:29 am the vehicle was stopped across from Allen W. Robert's School with occupants of the vehicle in and around the vehicle, including a 16 year old juvenile. Due to the vehicle being stopped on the side of the road and the occupants being in and around the vehicle, Corporal Wilson investigated to make sure there were no problems with the vehicle or emergencies with the occupants. Upon speaking with the occupants he detected a strong odor of an alcoholic beverage emanating from the interior of the vehicle and after investigating the odor, found an opened bottle of whisky. It was determined that the bottle belonged to Ms. Mongiello. The driver was issued summonses for provisional driver's license violations and both were given mandatory municipal court dates. The juvenile was turned over to an adult.

01-19-2014: Patrolman Andrew Diamond charged Judith L. Gropper, age 43, of Berkeley Heights with operating a vehicle while her driver's license was suspended after a random license plate inquiry revealed the suspension. She was given a mandatory municipal court date.

01-20-2014: Patrolman Joseph DiParisi charged Andrew N. Allen, age 38, of Springfield with operating a vehicle while his driver's license was suspended after a random license plate inquiry revealed the suspension. He was given a mandatory court date.

01-20-2014: Patrolman Joseph DiParisi charged Rashawna S. Jones, age 35, of Belleville with operating a vehicle with a suspended registration after a random license plate inquiry revealed the suspension. She was given a mandatory court date.

01-20-2014: Sergeant Daniel Henn charged Robinson Marvilus, age 25, of Elizabeth with operating a vehicle while his driver's license was suspended after his vehicle was stopped for an equipment violation.
