3. In addition to the above-stated salaries, longevity shall be paid to each listed full time employee pursuant to the terms of Section 4 of Ordinance 2008-09.

4. All other classified positions in the Borough of New Providence shall be Compensated in accordance with the rates of compensations established by Ordinance 2008-09 entitled "An Ordinance Fixing the Minimum and Maximum Rates of Compensation for Certain Offices and Positions of Employment Established and Maintained In and For the Borough of New Providence" and shall be paid on a quarterly basis or in such manner as shall be further ordered.
