WHEREAS, said Director may also approve the insertion of any item of appropriation for equal amount.

NOW THEREFORE BE IT RESOLVED the Mayor and Borough Council of the Borough of New Providence, County of Union and State of New Jersey, hereby requests the Director of the Division of Local Government Service to approve the insertion of item of revenue in the Budget of 2011 in the sum of \$5,000.00, which item is now available as revenue from the State of New Jersey, Division of Highway Traffic Safety.

BE IT FURTHER RESOLVED that a like sum, be and the same is hereby appropriated under the captions of:

DUI Enforcement – Drive Sober or Get Pulled Over \$5,000.00

BE IT FURTHER RESOLVED that two (2) certified copies of this resolution be furnished to said Director of Local Government Services.
