Councilperson Lesnewich submitted the following resolution, which was duly seconded by Councilperson Cucco.

WHEREAS, on May 23, 2011, Mayor and Borough Council approved Resolution 2011-147 authorizing a contract for Professional Tax Appraisal Services to Value Research Group; and

WHEREAS, said contract was awarded for a one year term; and

WHEREAS, the Tax Assessor has advised additional tax appeal services are required; and

WHEREAS the Tax Assessor has requested Resolution 2011-147 be amended to authorize tax appraisal services for the remainder of the 2012 calendar year in an amount not to exceed \$105,000.00 ; and

WHEREAS, the maximum amount of the contract is not to exceed \$105,000.00, and said funds are available and have been certified by the Chief Financial Officer.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of New Providence that they hereby agree to amend Resolution 2011-147 and authorizing the contract with Value Research Group for Tax Appraisal Services, for an amount not to exceed \$105,000.00.



Please place this item on the Agenda for Mayor and Council approval to amend the contract amount for Value Research Group. I am requesting an additional \$10,000 to cover invoices from February 3, 2012 to May 23, 2012.

There are several properties under appeal for multiple years which are not settled. The Court has ordered the preparation and exchange of appraisal reports, and during the next several weeks there are settlement conferences and trial dates scheduled. As such in order to have continuity in our appraisal services I ask that the contract with Value Research be extended to the end of December 2012 for an amount not to exceed \$50,000
