WHEREAS, these bicycles have been unclaimed for a period in excess of six months and said property is not necessary for public use now or in the future and the Police Department desires to dispose of same in the manner provided by law at a public auction.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of New Providence, in the County of Union and State of New Jersey, that they do hereby authorize the Chief of Police of the New Providence Police Department to dispose of the personal property set forth in the inventory attached in the manner provided and pursuant to the provisions of N.J.S. 40A:14-157.
