WHEREAS, the New Providence Rescue Squad, has reviewed the bid from VCI Emergency Vehicle Specialists and recommends the be awarded to same, subject to review of bid documents by the Borough Attorney; and

WHEREAS, Funding for the project is available in the following capital account:
