TITLE: RESOLUTION AWARDDING CONTRACT FOR SNOW REMOVAL  
EQUIPMENT AND LABOR FOR 2015-2019 SEASONS TO WOODLAND  
BUILDERS

Councilperson Muñoz submitted the following resolution, which was duly  
seconded by Councilperson Galluccio.

WHEREAS, the Borough of New Providence advertised to receive bids for snow  
removal equipment and labor for the 2014-2019 seasons, on September 3, 2014 and  
on October 22, 2014; and

WHEREAS, the Borough received no bids on either occasion; and

WHEREAS, on November 17, 2014 the Mayor and Borough council authorized the  
Borough Administrator and Manager of Public Works to negotiate for snow removal  
equipment and labor for the 2015-2019 seasons; and

WHEREAS, the Manager of Public Works has negotiated with Woodland Builders  
to provide snow removal equipment and labor for the 2015-2019 seasons at the rates  
listed in the attached memo, dated November 26, 2014; and

WHEREAS, the Chief Financial Officer has certified that there are funds available  
in the 2015 municipal budget, and will be available in the 2016, 2017, 2018 and 2019  
municipal budgets within the budget of the Streets and Roads Division; and

WHEREAS, it is the recommendation of the Borough Administrator and  
Director of Public Works that a contract be awarded to Woodland Builders.

NOW THEREFORE BE IT RESOLVED that the Mayor and Borough Clerk be  
authorized to execute the appropriate contract upon submission of the necessary proof of  
insurance coverage as required by the specifications, to the satisfaction, review and  
approval of the Borough Attorney.

As you are aware, our Plowing contract is up at the end of the year. Our current contract hasn't increased since 2013. I have negotiated a new contract with our current plowing contractor Woodland Builders. 2015 price will not increase. There will be a 5 dollar increase per hour per plow for 2016, 2017 and an additional 5 dollars per hour per plow for 2018, and 2019. Sidewalk and extra driver's rates will not increase. Most of the council might not be aware of this but before Woodland Builders started plowing for us we had to pay the contractor a guarantee of 500.00 per truck before the winter started which came out to 3000.00. They got that even if it didn't snow. Woodland Builders doesn't charge any guarantee fee.
