WHEREAS, the Borough of New Providence advertised for bids for the following services, for a total of thirty-eight (38) municipally-owned properties:

- 1) Grass cutting services for a period of one hundred fifty-five (155) weeks.
- 2) Spring Cleanup for a period of five (5) years.
- 3) Fall Cleanup and Mulching Service for a period of five (5) years.

under the general heading of a contract to be commonly known as "Grass Cutting Services And Related Work For Municipally-Owned Properties" for the period April 1, 2015 to October 31, 2019; and

WHEREAS, on March 13, 2015 three (3) bids were received; and

WHEREAS, the lowest, most responsible bid received was from D'Onofrio & Sons, Inc. Landscaping, 47 Van Tess Terrace, Maplewood, N.J. 07040, in the maximum, gross amount of \$207,195.00 as further denoted as follows:

BE IT FURTHER RESOLVED that the Mayor and Borough Council of the Borough of New Providence, County of Union and State of New Jersey hereby award a contract for the five (5) years indicated services to the firm of D'Onofrio & Sons, Inc. Landscaping, 47 Van Tess Ter, Maplewood, N.J. 07040, in the maximum amount of \$207,195.00 for five (5) years commencing April 1, 2015 to October 31, 2019.

BE IT FURTHER RESOLVED the Mayor and Borough Clerk be authorized to execute the implementing contract to effectuate obtaining said services, upon submission of the following items by D'Onofrio & Sons, Inc. Landscaping to the review and satisfaction of the Borough Attorney:

- 1) Documents of required insurance coverage in conformance with the bid document.
- 2) Execution and return of the proposed contract agreements.
