WHEREAS, the Borough of New Providence advertised for bids for solid waste and vegetative waste collection for a period of 3 or 5 years; and

WHEREAS, on March 31, 2015 one (1) bid was received; and

WHEREAS, the bid received was from Suburban Disposal Inc., 544 Montesano Rd., Fairfield, N.J. 07004, as follows:

WHEREAS, the Public Works Manager, has reviewed said bid and recommends the award of a five (5) year contract to Suburban Disposal, Inc. for the collection of solid waste and vegetative waste for the borough of New Providence; and

WHEREAS, the Chief Financial Officer has certified as to the availability of funds to pay for these services to be charged to accounts, 340-2-14325 and 340-2-14330, in the 2015, 2016, 2017, 2018, 2019 and 2020 municipal budgets.

BE IT FURTHER RESOLVED that the Mayor and Borough Council of the Borough of New Providence, County of Union and State of New Jersey hereby award a contract for five (5) years to the firm of Suburban Disposal Inc., 544 Montesano Rd., Fairfield, N.J. 07004, in the maximum amount of \$1,901,000.00 for five (5) years commencing May 1, 2015 to April 30, 2020.

BE IT FURTHER RESOLVED the Mayor and Borough Clerk be authorized to execute the implementing contract to effectuate obtaining said services, upon submission of the following items Suburban Disposal Inc., to the review and satisfaction of the Borough Attorney:

- Documents of required insurance coverage in conformance with the bid document.
- 2) Execution and return of the proposed contract agreements.

Re: Garbage bid

As you are aware we had to go to bid for garbage, grass, brush, leaves and bulk collection since First Occupational went out of business last year. We had 3 companies pickup the bid package and only one submitted a bid. Our current price is as follows.

2015 - \$ 328,847.82 plus bulk estimated 17,250= \$346,097.82 2016 - \$ 333,780.54 plus bulk estimated 17,500= \$351,280.54

2017 – No increase same as 2016. Last year of there contract.

Suburban disposals proposal is as follows everything is included in their price.

2015 - \$373,000.00 2016 - \$373,000.00 2017 - \$373,000.00 2018 -\$ 385,000.00 2019 - \$397,000.00

As you can see there is an increase of \$26,902.18 for year 2015 which will really be an increase of \$17,442.95 if we award there contract starting May 1 2015. The increase for 2016 will be \$ 21,719.49. The price for 2017 is the same as 2016.

I recommend awarding Suburban Disposal the contract. They have been doing the collection since May 2014 when they took over First Occupational contract and we have not had any problems. They have done a better job especially with the bulk collection.
