TITLE: RESOLUTION AUTHORIZING PURCHASE IN EXCESS OF \$17,500.00 FOR PASSAIC VALLEY COACH LINES, COMMUNITY ACTIVITIES CAMP TRANSPORTATION AT 10% LESS THAN STATE CONTRACT

Councilperson Muñoz submitted the following resolution, which was duly seconded by Councilperson Galluccio.

WHEREAS, the Borough of New Providence has a need to acquire bus transportation services for the Community Activities Department as a non-fair and open contract pursuant to the provisions of NSJA 19:44A-20.5 and as an exception to bidding pursuant to NJSA 40A:11-5(4) because the cost of the purchase is in excess of 10% less than the current State Contract price, and

WHEREAS, the Director of the Community Activities Department has determined and that the value of the service will exceed \$17,500.00, and

WHEREAS, the anticipated term of this contract is for the 2015 summer camp season, and

WHEREAS, Passaic Valley Coach Lines has submitted a proposal dated May 8, 2015, indicating it will provide the service for \$20,053.00, and

WHEREAS, Passaic Valley Coach Lines has completed and submitted a Business Entity Disclosure Certification which certifies that Passaic Valley Coach Lines has not made any reportable contributions to a political or candidate committee in the Borough of New Providence in the previous one year, and that the contract will prohibit Passaic Valley Coach Lines from making any reportable contributions through the term of the contract, and

WHEREAS, the cost of said service is \$20,053.00 and funds are available in account 45--002-500-2-59006 and have been certified by the Chief Financial Officer, attached hereto, and

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of New Providence:

That the purchase of bus transportation for the 2015 Camp programs in the Community Activities Department is authorized from Passaic Valley Coach Lines, 71 River Road, Chatham, NJ 07928, as described herein.

1. That the Business Disclosure Entity Certification and the Determination of Value be placed on file with this resolution.
2. This contract is awarded without competitive bidding in accordance with N.J.S.A. 40A:11-5(4) of the Local Public Contracts Law because the cost of the purchase is in excess of 10% less than the current State Contract price.
3. That Passaic Valley Coach Lines shall comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27 (Affirmative Action), N.J.S.A. 52:32-44 (Business Registration), and the Borough's insurance requirements.

On Thursday, May 7, 2015 bids were received for Teen Venture Camp bus transportation. One bid was received from Stout's Charter Service of Trenton, NJ in the amount of \$34,533 (for 2015) and \$35,563 (2016). This bid exceeded the estimated cost.

It is therefore requested that the bid be rejected.

Quotes were subsequently received from other vendors one of which has a State Contract (see attached). We recommend Passaic Valley Coaches as their quote is 10% less than the State Contract amount.
