NOW THEREFORE BE IT RESOLVED the Mayor and Borough Council of the Borough of New Providence, County of Union and State of New Jersey, hereby requests the Director of the Division of Local Government Service to approve the insertion of item of revenue in the Budget of 2015 in the sum of \$ 100,000.00 which item is now available as revenue from the Federal Emergency Management Agency.

This office is pleased to inform you that the Federal Emergency Management Agency (FEMA) has awarded the Borough of New Providence a Hazard Mitigation grant for a generator project. The period of performance is May 19, 2015 through May 19, 2018, with an expenditure deadline of May 19, 2017. The total project cost is \$158,500.00 with a Federal share of \$100,000.00, and a non-Federal share of \$58,500.00.
