TITLE: RESOLUTION PROVIDING FOR THE INSERTION OF ANY SPECIAL ITEM OF REVENUE IN THE 2017 BUDGET PURSUANT OF N.J.S. 40A:4-87 CHAPTER 159, P.L. 1948, 2017 NEW JERSEY BODY ARMOR REPLACEMENT FUND

Councilperson Madden submitted the following resolution, which was duly seconded by Councilperson Muñoz.

WHEREAS, N.J.S. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the Budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the Budget; and

WHEREAS, said Director may also approve the insertion of any item of appropriation for equal amount.

NOW THEREFORE BE IT RESOLVED the Mayor and Borough Council of the Borough of New Providence, County of Union and State of New Jersey, hereby requests the Director of the Division of Local Government Service to approve the insertion of item of revenue in the Budget of 2017 in the sum of \$2,508.63, which item is now available as revenue from the NJ Division of Criminal Justice, 2017 Body Armor Replacement Fund Program in the amount of \$2,508.63..

BE IT FURTHER RESOLVED that that a like sum of \$2,508.63 is hereby appropriated under the captions of Body Armor Replacement Fund Program - 2017; and

BE IT FURTHER RESOLVED, that the above is the result of funds from NJ Division of Criminal Justice in the amount of \$2,508.63.
