WHEREAS, N.J.S. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the Budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the Budget; and

WHEREAS, said Director may also approve the insertion of any item of appropriation for equal amount.

NOW THEREFORE BE IT RESOLVED the Mayor and Borough Council of the Borough of New Providence, County of Union and State of New Jersey, hereby requests the Director of the Division of Local Government Service to approve the insertion of items of revenue, as listed below, in the Budget of 2017 in the sum of \$1,950.00, which item is now available as revenue from Groundwork Elizabeth Inc., in the amount of \$1,950.00.

BE IT FURTHER RESOLVED that a like sum of \$1,950.00 is hereby appropriated under the captions of New Providence Community Garden.

BE IT FURTHER RESOLVED, that the above is the result of funds from the Union County Means Green Community Gardening Program in the amount of \$1,950.00.
