SUBJECT: Portable Ice Rink

In 2016, the Borough received a matching KRTF Grant from Union County in the amount of \$20,000. The amount was significantly lower than we had anticipated and made us rethink our original proposal of constructing a separate, multi-use facility for different kinds of hockey use. The original grant proposal was seeking a lit, in-line hockey rink near the Community Pool that could be flooded for ice hockey in the winter.

The recent extended cold spell here in New Providence, has given residents the opportunity to utilize the pond at Oakwood Park much earlier in the season than we are accustomed to. The "pond" has quickly become a popular spot for our residents to enjoy family skating and pond hockey. On any given day/time you will see adults and kids taking advantage of the ice. To ensure the safety of the skaters, we have divided the ice into two sections, Pond Hockey side and Family Skate side, using jersey barriers and clear signage, but would like to be able to offer a better separation of these two activities.

Once the temporary budget is in place on Friday, January 5, 2018, I am recommending the purchase of a Complete NiceRink Kit from My Backyard Sports. An additional sheet of ice will allow us to further separate the hockey players and family skaters and create a safer environment for everyone. As a courtesy, we have been in contact with the New Providence Community Pool Board about putting a temporary sheet of ice on top of the Community Basketball courts to which they have no objection. The purchase order for the rink and installation will be an amount not to exceed \$8000. Please see quotes on the next page.


