MEMORANDUM

To: Wendi Barry

Date: 4/16/2018

After snowstorm Quin on 3/8/2018 we needed help removing all the trees and branches due to emergency situation. I tried to call Taylor Rental and Pioneer Rental to see if they had any chippers to rent, which they didn't.

I called Woodland Builders who are employed by the borough as our plowing contractor. He supplied a backhoe with a 2 in 1 bucket and two big dump trucks as well as a chipper for us to rent. I then called Charlie Mazzucco Masonary and he supplied us with a small track machine that had a claw bucket and two dump trucks. Human backhoe said his truck was available if we needed it which I hired. I negotiated a rate of \$1800 per day for Woodlands machine and 2 big trucks plus \$350.00 per day for the chipper, Charlie Mazzucco machine and 2 trucks for \$1500.00 per day and Human backhoes truck for \$500.00 per day.

All brush went to S Rotondi and sons and the woodchips went to the DPW yard where I have a contractor coming to remove them for free.
