AGREEMENT

Agreement made this _____ day of _____, 2018 by and between the Borough of New Providence (herein the Borough) and New Providence PBA Local 132 (herein the PBA).

Whereas the Borough and the PBA are parties to a Collective Negotiations Agreement covering the period January 1, 2015 through December 31, 2018; and

Whereas Article IV: Salaries, Sections B and C provide for annual stipends in the amount of \$2,000.00 for assignments made at the direction of the Chief for Corporals and Investigators; and

Whereas the Borough intends to provide for a new assignment by the Chief for a School Resource Officer and further intends to pay the newly assigned officer a like stipend of \$2,000.00 under the same terms and conditions set forth as aforesaid in Article IV: Salaries; and

Whereas the PBA is willing to approve these terms and conditions:

Now therefore in consideration of the mutual covenants and undertakings herein set forth the parties agree as follows:

1. The parties agree that the Borough has the right to establish the assignment of School resource Officer and the Borough herewith makes said assignment.
2. The parties further agree that there shall be an annual stipend of \$2000.00 added to the salary of the employee assigned as the School Resources Officer for so long as that officer is assigned to that position. The \$2,000.00 stipend will be added to the base rate of compensation for all purposes for the duration of the assignment.
