TITLE: RESOLUTION AMENDING RESOLUTION 2018-066 "RESOLUTION AWARDING CONTRACT TO BROADWAY ELITE TOURS, DBA PASSAIC VALLEY COACH, 71 RIVER ROAD, CHATHAM, N.J. 07928 FOR BUS TRANSPORTATION SERVICES FOR COMMUNITY ACTIVITIES AND SENIOR PROGRAMS" ADOPTED FEBRUARY 2, 2018

Councilperson Muñoz submitted the following resolution, which was duly seconded by Councilperson Kapner.

WHEREAS, the Borough of New Providence adopted Resolution 2018-066 "Resolution Awarding Contract To Broadway Elite Tours, Dba Passaic Valley Coach, 71 River Road, Chatham, N.J. 07928 For Bus Transportation Services For Community Activities And Senior Programs", on February 26, 2018, for transportation services for the years 2018, 2019 and 2020; and

WHEREAS, the maximum contract amount was estimated for a five (5) week program; and

WHEREAS, due to the continued success of the program additional weeks were provided; and

WHEREAS, due to the expanded program it is necessary to amend the maximum contract amounts to \$22,000.00 for 2018, \$23,000 for 2019 and \$24,000 for 2020; and

WHEREAS, the Chief Financial Officer has certified as to the availability of funds to pay for these services to be charged to the 2018, 2019 and 2020 municipal budget account T-45-56-850-806-000000.

NOW THEREFORE BE IT RESOLVED that the Mayor and Borough Council of the Borough of New Providence, County of Union and State of New Jersey they hereby amend resolution 2018-066 for Broadway Elite Tours, Dba Passaic Valley Coach, 71 River Road, Chatham, N.J. 07928, increasing the maximum contract amounts to \$22,000.00 for 2018, \$23,000 for 2019 and \$24,000 for 2020.

SUBJECT: Amending Resolution 2018-066

I am requesting an amendment to resolution **2018-066** which awarded a contract to Broadway Elite Tours, Db a Passaic Valley Coach for Community Activities and Senior Programs.

This year, we added an additional week of programming for Teen Venture Camp in response to the demand we have each year for this program. This additional programming will put us over the allotted amount of \$18,000 by \$2,571 as stated on Resolution 2018-066. This amount does not include use by senior programs.

In looking ahead to the remaining two years of the contract I am requesting the following "not to exceed" dollar amounts by year:

2018 - \$22,000

2019 - \$23,000

2020 - \$24,000
