TITLE RESOLUTION ACCEPTING THE PROPOSAL OF MASER CONSULTING, P.A. FOR PROFESSIONAL ENGINEERING AND CONSTRUCTION ADMINISTRATION SERVICES REGARDING LIVINGSTON AVENUE ROADWAY IMPROVEMENTS

Councilperson Muñoz submitted the following resolution, which was duly seconded by Councilperson Madden .

WHEREAS, the Borough of New Providence acquired Professional Engineering Services as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19-44A-20.5; and

WHEREAS, Maser Consulting was awarded a contract with the Borough of New Providence via Resolution 2017-018 to provide professional engineering services; and

WHEREAS, Maser Consulting Services has submitted a proposal dated August 31, 2018 indicating they will provide professional engineering and construction administration services relating to Livingston Avenue Roadway Improvements, for an amount not to exceed \$22,000.00; and

WHEREAS, the fees assessed with this proposal are contained in said contract; and

WHEREAS, the maximum amount of the contract is not to exceed \$22,000.00, and said funds are available from the following accounts:

and have been certified by the Chief Financial Officer; and

Maser Consulting P.A. (Maser Consulting) is pleased to present the following proposal for construction administration services for proposed improvements to Livingston Avenue (Springfield Avenue to Marion Avenue). The proposed Scope of Services below outlines the work to be completed by Maser Consulting.

As you are aware, the Borough of New Providence has received a Grant from the New Jersey Department of Transportation (NJDOT) totaling \$310,000.00 for the improvements to Livingston Avenue. The total funding is allocated to improve Livingston Avenue from Springfield Avenue to the intersection of Marion Avenue. Please note that the roadway improvements were recommended to be awarded to American Asphalt & Milling Services LLC, in the amount of \$285,687.59.

Based on the above, Maser Consulting will provide the following construction administration for the project:

SCOPE OF SERVICES

PHASE 1.0 CONSTRUCTION ADMINISTRATION (Springfield Avenue to Marion Ave.):

Work to be completed under Livingston Avenue roadway improvements (Springfield Avenue to Marion Avenue) includes new sidewalk installation, removal and replacement of existing sidewalk, removal and replacement of curbing, installation of handicap ramps, roadway base repairs, roadway milling, roadway paving and striping. Upon award of the contract, Maser Consulting shall provide the following services:

- Schedule and attend pre-construction meeting.
- Review and recommend approval of Contractor's applications for payments.



- Review and recommend approval of Contractor's change orders, if any.
- Prepare final punch list.
- Review final as-built drawings provided by Contractor.
- Provide final completion certificate.
- NJDOT Grant Administration

Maser Consulting shall provide part-time/full-time construction management services on an as-needed basis, depending on the complexity of construction for any given day. We will utilize an on-site Field Manager for the duration of the project in order to provide consistency throughout construction.

From experience with similar sized projects, Maser Consulting estimates that the duration of construction should be approximately six (6) weeks from the start of work. In addition, Maser Consulting anticipates that there will be three (3) weeks of part-time construction administration services for the Contractors to complete the punch list items. The goal is to construct the entirety of the project during the 2018 construction season. Please note that this project is weather dependent. Should inclement weather occur, the construction schedule may be altered. Should any additional work be awarded for construction, the construction administration portion of the contract shall be amended to reflect the additional effort of inspection services.

Daily inspection reports will be retained by Maser Consulting regarding the project. Maser Consulting shall review and prepare Contractor's payments as well as change orders. If unacceptable work or material is supplied by the Contractor, immediate corrective action shall be taken by Maser Consulting on behalf of the Borough.

Prior to completion, a final punch list shall be created by the Inspector and completion deadlines shall be scheduled for all open items. Upon completion of the punch list items, a final site inspection shall be scheduled with the Contractor and the Borough in order to close out the project. Maser Consulting will prepare the paperwork for final inspection and final payment for the Contractor. Should additional construction administration services be required, Maser Consulting shall coordinate with the Borough and inform the appropriate personnel of the status of construction. Maser Consulting will prepare the paperwork for payments for the Contractor and submittal to NJDOT for funding reimbursement.

PHASE 1.0 CONSTRUCTION ADMINISTRATION **\$15,500.00**

Maser Consulting will provide the services outlined for Livingston Street from Springfield Avenue to Marion Avenue for a cost not to exceed \$15,500.00. The hourly rates utilized for the project will be in accordance with the Borough Engineering Contract previously approved by Mayor and Council.

PHASE 2.0 (NJDOT Coordination for Reimbursement) **\$6,500.00**

Maser Consulting will provide services to coordinate and complete all paperwork with the NJDOT for the Borough to receive reimbursement for NJDOT Grant for this project. Maser Consulting will provide these services for a cost not to exceed \$6,500.00. The hourly rates

utilized for the project will be in accordance with the Borough Engineering Contract previously approved by Mayor and Council.

Maser Consulting will provide the services outlined in PHASES 1.0, and 2.0 for a **COST NOT TO EXCEED \$ 22,000.00**
