TITLE: RESOLUTION AWARDDING CONTRACT TO SUBURBAN DISPOSAL, INC., 54 MONTESANO RD., FAIRFIELD, NJ 07004 FOR CURBSIDE COLLECTION OF SOLID WASTE AND GARDEN WASTE

Councilperson Muñoz submitted the following resolution, which was duly seconded by Councilperson DeSarno.

WHEREAS, the Borough of New Providence advertised for bids for solid waste and vegetative waste collection for a period of 3 or 5 years; and

WHEREAS, on March 10, 2020 one (1) bid was received; and

WHEREAS, the bid received was from Suburban Disposal Inc., 544 Montesano Rd., Fairfield, N.J. 07004, as follows:

Year 1	\$ 472,000.00
Year 2	\$ 486,000.00
Year 3	\$ 500,000.00
Year 4	\$ 519,000.00
Year 5	\$ 544,000.00

; and

WHEREAS, the Public Works Manager, has reviewed said bid and recommends the award of a five (5) year contract to Suburban Disposal, Inc. for the collection of solid waste and vegetative waste for the borough of New Providence; and

WHEREAS, the Chief Financial Officer has certified as to the availability of funds to pay for these services to be charged to the 2020, 2020, 2020, 2020 and 2020 municipal budgets.

BE IT FURTHER RESOLVED that the Mayor and Borough Council of the Borough of New Providence, County of Union and State of New Jersey hereby award a contract for five (5) years to the firm of Suburban Disposal Inc., 544 Montesano Rd., Fairfield, N.J. 07004, in the maximum amount of \$2,521,000.00 for five (5) years commencing May 1, 2020 to April 30, 2025.

BE IT FURTHER RESOLVED the Mayor and Borough Clerk be authorized to execute the implementing contract to effectuate obtaining said services, upon submission of the following items Suburban Disposal Inc., to the review and satisfaction of the Borough Attorney:

- 1) Documents of required insurance coverage in conformance with the bid document.
- 2) Execution and return of the proposed contract agreements.
