TITLE: RESOLUTION AMENDING RESOLUTION 2019-266 ENTITLED
“RESOLUTION APPROVING PROPOSAL TO THE UNION COUNTY
DIVISION OF PLANNING FOR GRANT FUNDS FOR THE MUNICIPAL
ALLIANCE FOR THE YEAR 2020-2021”

Councilperson Muñoz submitted the following resolution, which was duly seconded by Councilperson DeSarno.

WHEREAS, the Governor’s Council on Alcoholism and Drug Abuse established the Municipal Alliances for the Prevention of Alcoholism and Drug Abuse in 1989 to educate and engage residents, local government and law enforcement officials, schools, nonprofit organizations, the faith community, parents, youth and other allies in efforts to prevent alcoholism and drug abuse in communities throughout New Jersey.

WHEREAS, The New Providence Council of the Borough of New Providence, County of Union, State of New Jersey recognizes that the abuse of alcohol and drugs is a serious problem in our society amongst persons of all ages; and therefore has an established Municipal Alliance Committee; and,

WHEREAS, the New Providence Borough Council further recognizes that it is incumbent upon not only public officials but upon the entire community to take action to prevent such abuses in our community; and,

WHEREAS, the New Providence Borough Council was approved for funding to the Governor’s Council on Alcoholism and Drug Abuse through the County of Union for FY2021; in the amount of:

DEDR	\$ 16,822.00
Cash Match	\$ 4,205.50
In-Kind	\$ 12,616.50

and;

WHEREAS, due to the significant decrease in Drug Enforcement Demand Reduction Fund collections, the Governor’s Council on Alcoholism and Drug Abuse had announce a reduction to the previously awarded FY 2021 Municipal Alliance Program; and

WHEREAS, the FY 2020 Municipal Alliance Program was extended to September 30, 2020 adding a fifth quarter.

NOW, THEREFORE, BE IT RESOLVED by the New Providence Borough, County of Union, State of New Jersey hereby recognizes the following:

1. The FY 2021 grant program shall be funded for the period October 1, 2020 through June 30, 2021.
2. The New Providence Borough Council does hereby authorize submission of a strategic plan for the New Providence Municipal Alliance grant for fiscal year FY2021 in the amount of:

Cash Match	\$ 1,388.75
In-Kind	\$ 4,166.25

3. The New Providence Borough Council acknowledges the terms and conditions for administering the Municipal Alliance grant, including the administrative compliance and audit requirements.
